# Descriptif du poste

ODDO BHF is a Franco-German financial group with a history dating back more than 170 years. It was founded by a French family-owned bank and a German bank specialising in small and mid-sized companies. With 2700 employees, of which 1400 in Germany and Switzerland and 1300 in France and Tunisia, and more than 128 billion euros in client assets under management, ODDO BHF operates in three main business lines - private banking, asset management, and corporate and investment banking. The Group possesses a unique shareholder structure, as it is 65% owned by the Oddo family and 25% by its employees. This partnership approach guarantees long-term employee commitment. In 2022, ODDO BHF generated net banking income of 727 million euros, and as of 31 December 2022 it had more than 1,1 billion euros in consolidated shareholders' equity.

- Provide internal follow up of screening of prospective investment opportunities as well as tracking of the firm's investment pipeline
- Assist with monitoring of assets including review of monthly operating results and updating relevant internal monitoring / reporting templates
- Maintain appropriate deal database and document filing systems and ensure compliance with records retention procedures
